




What size bin do I need?

Roll-off bins, also known as “dumpsters” are billed at a minimal flat rate; each rental includes one (1) delivery placement, one (1) collection removal, transport mileage and landfill tipping. Rental fees are based on two-week assignment and container size. Businesses have the option of establishing a collection schedule; however, base rates apply, regardless of waste volume collected.

Pre-payment is required for residences and single-use contractors. Service requests are processed in order received; standard processing time is next business day. The Solid Waste Program is closed on tribal holidays.

Natural Debris Bin - \$175.00 Accommodates up to 12 pickup truck loads of tree limbs, branches, weeds, grass clippings and garden waste.		

In general, competitor waste collection providers operate for profit, causing their fee scales to be significantly higher.

COMPETITOR COMPARISON:

- **Delivery Fee:** \$90 - \$95 per container, per service
- **Container Removal Fee:** \$190 - \$210 per container, per service
- **Container Rental Fee:** \$3 - \$4 per container, per day
- **Landfill Tipping Fee:** \$35 - \$68 per ton, depending on material type and county of origin.

Resolution # LAND-2021-0667 mandates that tribal businesses, schools and affiliated government programs utilize the Shoshone-Bannock Tribes Solid Waste Program for standard waste collection (non-hazardous material).

Resolution # LAND-2021-0666 requires that businesses, schools and government sectors manage their own waste reduction programs.

TERMS AND CONDITIONS OF USE

- Maximum placement for **Temporary/Single-Use** rentals is 14-days, per delivery. **Permanent Placement** bins can establish a collection schedule or call for service as needed. **Unscheduled service requests are processed in order received, on-demand requests cannot be accommodated; standard processing time is next business day.**
- Customer agrees to provide unobstructed access, with a 10' surrounding clearance for roll-off delivery and collection. \$40.00 will be charged for each "dry run" where driver cannot deliver or collect due to blocked access and/or insufficient entry space.

- Bin placement will be at driver’s discretion, necessary to prevent damage to overhead utility lines, visible well/septic, structures and fences. Drivers will not “drop” bin on uneven, water saturated or soft ground.
- Commercial truck and/or bin weight may cause ground disturbance. Customer agrees to indemnify and hold harmless the Shoshone-Bannock Tribes Solid Waste Program of any damage which may occur to property.
- Customer agrees to cease use of bin and immediately notify Solid Waste of potential hazard - i.e. missing lid pin, stripped crank, damaged cable, etc. Customer is responsible for safety oversight until bin can be replaced.
- Customer is responsible for loading of container. Drivers will not pick up excess or windblown materials surrounding bin.
- Customer agrees to not load bin over top rail. If driver is unable to close lid, tarp load or secure doors, load will be refused until customer removes excess material; dry run fees will apply.
- Customer agrees to disperse load weight equally. Drivers will refuse load if bin weight poses a lift or transport hazard, dry run fees will apply. *BUCKET LOADING CAUTION: waste dirt is a heavy material that shifts during transport, drivers will not accept “dirt mixed” loads.*
- Roll-off bins are property of the Shoshone-Bannock Tribes. Customer agrees to provide proper care and safekeeping of rental bin, at no time is customer authorized to utilize heavy equipment to compact contents or resituate placement. Customer will be liable for damage beyond reasonable wear and tear.
- Customer acknowledges responsibility for public disposal abuse; renters are advised to close bin lid when not in use and/or install fencing around disposal area. Temporary/Single-Use renters should request bin removal as soon as project is complete.
- Customer is rightful owner of bin content until the load is accepted, without protest, by county landfill or transfer station. Customer is liable if non-compliant load requires testing, treatment, storage, contracted disposal, causes damage to transport equipment or requires backhoe/excess labor for unloading.
 - No fireplace ashes or burn barrel debris
 - No refrigerator or air conditioners
 - No sealed pressure vessels or flammables
 - No florescent light tubes
 - No dead animals
 - No fryer/commercial cooking oil
 - No wet paint, pesticides or herbicides
 - No vehicle fluids – gas/oil/antifreeze
 - No dirt, gravel, concrete, brick or railroad ties
 - No tires
- Natural debris bins are for tree limbs, branches, grass clippings and garden waste only. Natural debris bins contaminated with household or construction waste will be charged the full rate of a 40 yd rental - \$455.00.
